Pre-Arrival – Immigration Documents

- 收到I-20，支付SEVIS费(美金200刀，人民币1381元)，预约签证面试

Receive I-20 and pay SEVIS fee (\$200, 1381 RMB) and make visa appointment

- 费用将从6月24日起由200刀上调至350刀（2418元） Fee is being increased from \$200 to \$350 (2418 RMB) as of June 24.

行前 Pre-Arrival

- 带去签证面试的材料 Items to take to visa appointment
 - 有效护照和I-20/DS-2019 Valid passport and I-20/DS-2019
 - 财力证明文件 Financial documents
 - 英语能力证明（如托福或雅思成绩） Evidence of English ability (example: TOEFL or IELTS score)
 - 学习完成之后无意留在美国的证明 Evidence of intent to depart the U.S. after completion of studies
 - SEVIS收据 SEVIS fee receipt
 - 照片 Photograph



行前 Pre-Arrival

- 申请美国签证，请记住以下要点：
When applying for their U.S. visa, remember:
 - 与中国的紧密联系-国内的亲人
Ties to home country – Dependents remaining at home
 - 会说英语 Speak English
 - 态度良好 Maintain positive attitude
 - 了解自己申请的项目，知道它如何与自己长期计划相结合
Know the program and how it fits into their long-term plans
 - 简明扼要 Be brief





行前 Pre-Arrival

- 确认抵达哥伦布国际机场 (CMH) 的旅行安排
Confirm travel arrangements to John Glenn Columbus International Airport (CMH)
- 在你I-20表格中的起始日期前30天你可以进入美国（不可以早于2019年7月21日，星期日前抵达，除非从另一个美国大学转SEVIS记录）
You can enter the U.S. up to 30 days before the start date on your I-20 (no sooner than Sunday, July 21, 2019), unless transferring SEVIS record from another U.S. institution
- 保证护照至少有六个月的有效期 Keep passport valid for at least six months into the future



在入境口岸-海关与边境保护局 At the Port of Entry – Customs & Border Protection

- 在所有材料准备齐全但被拒绝入境的情况很罕见 Denial of entry is extremely rare
- 请随身携带并拿出以下文件（文件应放在随身携带的行李箱里）
Have in hand at CBP (pack in *carry on* luggage!):

必须准备的文件 Required:

- 有效的含有F-1签证的护照 Passport with valid F-1 visa
- I-20
- 俄亥俄州立大学录取通知书 Ohio State admission letter



在入境口岸-海关与边境保护局 At the Port of Entry – Customs & Border Protection

- 建议准备文件 Recommended:
 - 财产证明 Financial documentation (bank statement copy)
 - 秋季学期的全日制课表，如果可以提供 Autumn Semester full time course schedule, if available
- 学生可能会被要求进行“第二次检查”。 Students may be asked to go through "secondary inspection."

移民法限制和福利 Immigration Restrictions and Benefits

- 为了保持您的F-1学生签证身份： In order to maintain F-1 student immigration status:
 - 到达哥伦布后，在buckeyelink上面上传自己在美国的住址。更改美国住址需在更改住址后的10天内在buckeyelink上上传自己的新住址 Update local address upon arrival and within 10 days of any address change
 - 全日制学生在秋季和春季学期至少要上12学分的课程。12个学分里，至少9学分必须是实体课（不能全是网课） Enroll full time, 12 credit hours, during each semesters. Most credit hours cannot be on-line
 - 学校不要求夏季学期学生必须上暑课，除了将要毕业的学生 During summer term enrollment is not required, except for graduating students.
